Introduction

This statistical release reports on National Indicator 52 (NI 52) – the take up of school lunches. It covers the 2008-2009 financial year (April 2008 to March 2009) in maintained primary, special and secondary schools, city technology colleges and academies in England. It is based on data provided by Local Authorities as part of the 2009 School Food Trust (SFT) and Local Authority Caterers Association (LACA) annual Local Authority (LA) survey. It provides at national, regional and local level information on the take up of school lunches and the coverage of the data in England in two categories: primary schools together with special schools; and secondary schools, together with academies and city technology colleges.

NI 52: take up of school lunches, 2008-2009

NI 52 provides information on the take up of school lunches in two categories of catering providers:

1. *LA catered or contracted provision.* Catering services provided directly by the LA itself (direct service organizations – DSO), or services contracted by the LA from other catering providers
2. *Non-LA catering provision.* Catering services contracted directly by schools from catering providers other than the LA, and provision organized by schools themselves (“in-school”).

All 150* LAs responded to the 2009 survey and provided some information. 145 LAs provided “usable” data for primary schools and 139 LAs provided “usable” data for secondary schools.

“Usable” data means data collected using NI 52 methodology covering the entire financial year. In the five LAs for which there was no primary school data, three provided partial data, one provided no data, and one provided data where there were concerns over quality.[†] In the eleven LAs for which there was no secondary school data, two have no secondary schools,[‡] two provided partial data, three provided no data, and four provided data where there were concerns over quality.

NI 52: Take up of school lunches, 2008-2009:

- **Primary and special schools: 39.3%**
- **Secondary schools, academies and city technology colleges: 35.1%**

Note: These values SHOULD NOT be compared with previously published national or regional take up data. For comparison with 2007-2008, please see next page.

Percent take up and coverage (percentage of schools for whom data are reported) for all catering service provision in England, by sector by region, are shown in Table 1. Results for schools with LA catered or contracted services, by sector by region, are shown in Table 2. Results for schools with non-LA catering provision, by sector by region, are shown in Table 3.

Comparison with previous data

Take up figures for 2008-2009 should not be compared directly with published national take up figures for previous years for four reasons:

1. There are fundamental differences between the NI 52 methodology and the previous 'usual' method for calculating take up, especially in the secondary sector
2. The number of LAs for which data were reported in 2008-2009 was 145 (97% out of 150 LAs) for primary and 139 (93%) for secondary, compared with 97 (65%) and 78 (52%), respectively, in 2007-2008
3. The NI 52 data includes both LA catered and contracted provision and non-LA provision. Previous reporting related mainly to LA catered or contracted provision
4. The way in which take up is calculated for schools with Free School Meal-only provision.

A subset of 82 LAs provided data in 2007-2008 and 2008-2009 for primary school services, and a different subset of 81 LAs provided data for secondary school services using NI 52 methodology (Table 5). For these subsets, the change in take up in primary schools was +0.1% and the change in take up in secondary schools was +0.5%.

This is the best current indicator of the true change in take up between 2007-2008 and 2008-2009.

Notes to editors

Definitions

1. NI 52 (take up of school lunches) is one of 198 indicators in the National Indicator Set. See Annex 1 for the technical definition. Further guidance is provided at the time of data collection.
2. Take up refers to the percentage of full-time pupils attending schools who have a lunch that is provided either by the school or local authority during the previous financial year.

Data Collection, Coverage and Quality

1. NI 52 data are collected via the School Food Trust (SFT) and Local Authority Caterers Association (LACA) joint annual survey of Local Authorities (LAs).
2. 2009 is the first year of NI 52 data collection.
The figures reported here should not be compared with national or regional take up figures reported in previous years. Results for comparison between 2007-2008 and 2008-2009 are shown in Table 5.
3. The figures for take up reported in previous years have primarily related to schools with LA catered or contracted lunch services. The percentage take up reported has been based on that reported by the LAs, rather than calculated from raw data. We are aware that LAs have used several different methods to calculate take up, and this differing basis for calculation means that figures at LA level have not been strictly comparable in the past.
4. In accordance with NI 52 methodology, LAs are now required to provide information on the take up of school meals not only for their own catering or contracted services but for all schools across the LA. The two main virtues of introducing NI 52 relate to:
 - **Coverage** (% of schools in LA for whom data are reported):
LAs collect data for all schools in their LA, not just those for whom they provide or contract catering services
 - **Comparability**:
All LAs use a standardized methodology for calculating take up
5. The School Food Trust published a Technical Paper in December 2008.¹ This describes the fundamental differences in reporting between NI 52 and the “usual” methods used previously by LAs. It reported that the potential impact on reported take up resulting from the introduction of a standardised methodology was in the region of -0.6% for primary schools and -1.6% for secondary schools. This was based on analysis of data from the 2008 SFT/LACA annual survey, comparing a subset of LAs who reported take up data using their ‘usual’ method of calculation and using the NI 52 method. It did not, however, include the downward impact on estimates of take up resulting from the inclusion of LAs with schools with FSM-only provision. This impact is reflected in the take up figures reported for 2008-2009.

General

1. The School Food Trust has reported figures for take up in primary and secondary schools each year since 2006. The first annual survey of school meal take up in England was carried out by the Trust in May 2006 (and published in July 2006).² The second annual survey of school meal take up in England was carried out in April 2007 (and published in September 2007).³ The third annual survey of school meal take up was carried out jointly with LACA in April 2008 (and published in October 2008).⁴
2. Further information gathered from Local Authorities on school food provision will be reported in the Fourth annual survey report to be published in September 2009.

Rationale	<p>To assess the increase in healthy eating among children and young people by measuring school lunch take up, particularly those children entitled to a Free School Meal. Nationally, 43% of primary and 38% of secondary pupils have a school lunch. 16% of primary and 13% of secondary pupils have known entitlement to FSM and 13% of primary pupils (81% of those registered) of primary and 9.5% of secondary pupils (73% of those registered) of secondary pupils take up that entitlement. All school lunches are now required to meet tough nutritional standards that ensure that all the food provided by schools and local authorities in a school lunch is healthy and of good quality. Packed lunches provided by parents are not regulated and there are no mechanisms for establishing whether packed lunches meet the nutritional standards required for school lunches.</p>		
Definition	<p>School lunch take up refers to the number or percentage of full-time pupils on roll at maintained primary, secondary or special schools, academies and city technology colleges who have a lunch at school that is provided either by the school or the local authority during the previous financial year.</p> <p>In primary schools (includes special schools), the percentage take up is calculated using the formula:</p> $\left[\frac{\text{Reported number of meals served (paid plus free)}}{\text{Number of full time pupils on roll}} \right] \times 100$ <p>where the 'Reported number of meals served (paid plus free)' is based on the numbers reported by catering staff in the school.</p> <p>In secondary schools, the percentage take up is calculated using the formula:</p> $\left[\frac{\left[\frac{\text{Total income from lunchtime sales}}{\text{FSM equivalent price}} \right] + \text{total FSM provided}}{\text{Number of full-time pupils on roll}} \right] \times 100$ <p>where the 'Total income for lunchtime sales' is based on the till receipts for all sales of food provided for lunch during the period to which school lunch standards (including nutrient based standards from 2009) have been applied, and 'FSM equivalent price' is the monetary value in the dining room of a free school meal.</p>		

	<p>Free school meals are available to all children in non-working families, i.e. those where the adults do not work, or work for less than 16 hours per week. These families are reliant on 'welfare support payments' and are not able to claim the additional 'Working Tax Credit' that is available to low income working families (adults working 16+ hours per week).</p>		
	<p>The average for the year will be calculated as follows:</p> <p>Primary – divide the number of meals served over the period by the number of trading days in the period</p> <p>Secondary – divide the result of the numerator calculation by the number of trading days in the period.</p>		
<p>Formula</p>	<p>Average percentage point figures are calculated from returns made by all local authorities in an annual survey carried out by the School Food Trust. The data relate to one financial year, from April to March.</p> <p>Take the percentage take up in each of the schools in the authority which are subject to the nutritional standards for school food (all maintained schools, academies and city technology colleges) provided to one decimal place, and calculate the weighted average to one decimal place.</p> <p>Figures for primary and secondary school take up of lunches are reported on separately.</p>
