## NPS and Value Wales Statement

- On 5 September the Cabinet Secretary for Finance, Mark Drakeford provided a written statement of the National Procurement Service and Value Wales. The full statement can be accessed at:

- Within the statement it is noted that the NPS will, over time, cease to exist in its current form.
- The statement notes that a new procurement strategy will be developed enabling the full value of procurement to be realised nationally, regionally and locally.
- The statement describes that a smaller operation will be established to manage a reduced portfolio of national contracts.
- The statement notes that there will be an enhanced procurement policy and capability development approach

- At the time of the establishment of the smaller operation for managing national contracts live agreements will transition or novate to the new operation.
- There will be changes to our existing pipeline where it's identified that future tenders are better delivered on a regional or local basis.

### Current Frameworks

•Fresh Foods – went live August 2017 / 2 yrs +1yr+1yr / 14 Lots including all fresh & frozen meat/poultry; fruit & vegetables; dairy; bread & cakes and chilled ready to eat foods

•Packaged Foods – went live November 2017 / 2 yrs +1yr+1yr / Lots - all ambient food and beverages including biscuits; cereals; preserves and non-alcoholic drinks

•Alcoholic Beverages – went live September 2018 / 4 yrs / 4 Lots – draught, packaged & cask beers/ciders/lagers/stouts and wines & spirits





•Working with WRAP Cymru a sustainability Key Performance Indicator reporting tool was developed

•The tool represents a new mechanism by which NPS will monitor, evaluate and report on the sustainability performance of suppliers

•It will provide valuable data to support our approach to delivering well being for all.

•Two engagement events have been held with suppliers invited to test the tool and give feedback.
